In terms of Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and pursuant to the Outcome of Board Meeting submitted on 3rd October, 2021 for the Board Meeting held on 3rd October, 2021, we would like to inform that due to some Clerical error we are submitting the revised outcome, hence, the Board of Directors in their Meeting held on 3rd October, 2021 have *inter alia* considered and approved the following matters:
